AN ORDER REORGANIZING THE NAGA CITY PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) BY DESIGNATING RETIRED PROSECUTOR, ATTY. VICTOR DELA CRUZ, AS MEMBER OF THE BOARD VICE ATTY. MILAGROS FRANCIA:-

WHEREAS, Republic Act No. 6975, otherwise known as the "Department of the Interior and Local Government Act of 1990," mandates the establishment of a People's Law Enforcement Board (PLEB) in every city and municipality to hear and adjudicate citizen complaints against members of the Philippine National Police (PNP);

WHEREAS, the PLEB plays a vital role in ensuring accountability, integrity, and public trust in law enforcement by providing an impartial forum for addressing grievances against erring police officers;

WHEREAS, there is a need to ensure that the composition of the Naga City PLEB is consistent with the requirements of the law and responsive to the needs of the city;

WHEREAS, the position previously held by Atty. Milagros Francia as a member of the Naga City PLEB has become vacant due to her untimely passing last July 2024;

WHEREAS, retired Prosecutor Atty. Victor Dela Cruz possesses the qualifications, experience, and integrity necessary to contribute effectively to the work of the Naga City PLEB;

NOW THEREFORE, I, NELSON S. LEGACION, by the powers vested in me as the City Mayor of Naga under the laws of the Republic of the Philippines, do hereby order the following:

SECTION 1. REORGANIZATION OF THE NAGA CITY PLEB. The composition of the Naga City People's Law Enforcement Board is hereby reorganized by designating Retired Prosecutor Atty. Victor Dela Cruz as a member of the Naga City PLEB, replacing Atty. Milagros Francia.

SECTION 2. DUTIES AND RESPONSIBILITIES. The Naga City PLEB shall continue to perform its duties and responsibilities as provided under Republic Act No. 6975 and other applicable laws, ensuring the fair and efficient resolution of complaints against members of the Philippine National Police.
