BID BULLETIN

To all Prospective Bidders:

This Bid Bulletin is issued to clarify, amend, and supplement the bidding documents for the

1. **Various Infrastructure Projects (5), Cluster 1: 1 Lot**
2. **Various Infrastructure Projects (4), Cluster 2: 1 Lot**
3. **Various Infrastructure Projects (2), Cluster 4: 1 Lot**
4. **Various Infrastructure Projects (3), Cluster 6: 1 Lot**

All prospective bidders are hereby informed of the following project conditions and requirements:

1. **Project Engineer**
 - **Requirement:** One (1) Project Engineer is allowed per entire cluster of projects.
 - **Clarification:** The Project Engineer assigned to the cluster cannot be assigned to multiple clusters where the bidder has won additional bids.
2. **Foreman**
 - **Requirement:** One (1) Foreman is required for every individual project within the cluster.
 - **Clarification:** A Foreman assigned to one project cannot be reassigned to another project within the same cluster or any other cluster where the bidder has won the bid.
3. **Safety Officer**
 - **Requirement:** The same requirement applies as for the Foreman, i.e., one (1) Safety Officer is required for every project within the cluster.
 - **Clarification:** A Safety Officer assigned to one project cannot be reassigned to another project within the same cluster or any other cluster where the bidder has won the bid.
4. **Equipment**
 - **Requirement:** A complete set of equipment must be provided for each project within the cluster.
 - **Clarification:** Equipment utilized for one project within a cluster cannot be reused or reassigned to another project within the same cluster or any other cluster where the bidder has won the bid.
5. **Equipment and Personnel Reusability**
 - **Condition:** Both equipment and personnel (Project Engineer, Foreman, Safety Officer) cannot be reused by a winning bidder for another cluster where they have won a bid.
 - **Clarification:** Each cluster must have a distinct set of equipment and personnel, ensuring compliance with this condition for all awarded clusters.

- **Other Instructions:**
 - Prospective bidders are advised to factor in these requirements when preparing their bid proposals.
 - Failure to comply with these provisions may result in the disqualification of the bid or cancellation of the awarded contract.


