**A RESOLUTION AUTHORIZING THE CITY MAYOR TO UTILIZE THE CASH DONATIONS RECEIVED BY THE CITY OF NAGA FOR DISASTER RESPONSE IN VIEW OF THE DEVASTATION WROUGHT BY TROPICAL STORM "KRISTINE"**

**WHEREAS**, Tropical Storm "Kristine" has caused widespread devastation in the City of Naga, resulting in severe damage to infrastructure, livelihood, and homes, as well as disruption of essential services;

**WHEREAS**, cash donations have been received from various organizations, institutions, agencies and local government units to support disaster response efforts, reflecting the community's solidarity and commitment to recovery;

**WHEREAS**, there is an urgent need to utilize these funds to supplement the City's Quick Response Fund (QRF) to address the immediate needs of the affected individuals and families and to strengthen disaster preparedness, mitigation, and recovery efforts;

**WHEREAS**, the utilization of these donations for disaster-related expenditures such as relief and cash assistance, meals for clearing and clean-up operations, procurement of rescue materials and equipment, stockpiling of supplies for future weather disturbances, and other necessary activities aligns with the provisions of Republic Act No. 10121 (Philippine Disaster Risk Reduction and Management Act of 2010);

**NOW, THEREFORE**, upon motion duly seconded, the City Disaster Risk Reduction and Management Council (CDRRMC) of the City of Naga, in a meeting held on November 14, 2024 at the City Mayor's Office Conference Room, resolves as follows:

**RESOLVED, AS IT IS HEREBY RESOLVED:**

1. To authorize the City Mayor, Honorable Nelson S. Legacion, to utilize the cash donations received by the City of Naga for the following purposes:
  - a. Provision of relief and cash assistance to affected individuals or families;
  - b. Defraying the costs of meals for personnel involved in clearing and clean-up operations;
  - c. Procurement of rescue materials and equipment needed for disaster response operations;



- d. Supply and delivery of supplies needed for the distribution of cash and food supplies to affected families;
  - e. Supply and delivery of stockpile items for forthcoming weather disturbances; and
  - f. Other expenditures necessary for disaster preparedness, mitigation, and recovery, as determined by the City Mayor and City Disaster Risk Reduction Management Officer
2. To direct the City Accounting Office and City Treasurer's Office to ensure proper accounting and documentation of all expenditures from the donated funds, ensuring compliance with existing rules and regulations on fund utilization and auditing.
  3. To require the CDRRMO to monitor and evaluate the utilization of the funds and submit periodic reports to the CDRRMC and donors to ensure transparency and accountability.


