RESOLUTION NO. 2024-007

A RESOLUTION AUTHORIZING THE CITY MAYOR AND THE CITY ADMINISTRATOR TO IMMEDIATELY PROCURE DISASTER RESPONSE MATERIALS, INCLUDING WATERPROOF HANDHELD TWO-WAY RADIOS, MARINE ROPES, LIFE VESTS, AND LIFE BUOYS, TO ENHANCE THE CAPABILITIES OF BARANGAY AND CITY RESCUE AND RESPONSE TEAMS IN PREPARATION FOR THE THREAT OF SUPER TYPHOON "PEPITO"

WHEREAS, the Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) has issued a warning regarding the imminent arrival of Super Typhoon "Pepito," which poses a significant threat to the City of Naga and its residents;

WHEREAS, the safety and preparedness of the city's rescue and response teams are paramount in minimizing casualties and ensuring the efficient delivery of emergency services during disasters;

WHEREAS, there is an urgent need to equip both Barangay and City Rescue and Response Teams with disaster response materials, including waterproof handheld two-way radios, marine ropes, life vests, and lifebuoys, to enhance communication, rescue, and evacuation operations;

WHEREAS, Republic Act No. 9184, also known as the Government Procurement Reform Act, allows for emergency procurement in cases where a calamity or imminent danger to life and property exists, subject to proper documentation and adherence to auditing rules;

WHEREAS, the immediate procurement of these materials is deemed critical for the effective implementation of disaster preparedness and response plans for Super Typhoon "Pepito";

NOW, THEREFORE, upon motion duly seconded, the City Disaster Risk Reduction and Management Council (CDRRMC) of the City of Naga, in a meeting held on November 14, 2024,

RESOLVED, AS IT IS HEREBY RESOLVED:

- To authorize the City Mayor, Honorable Nelson S. Legacion, and the City Administrator, Joselito SA. del Rosario, to immediately procure the following disaster response materials:
 - a. Waterproof handheld two-way radios;
 - b. Marine ropes;
 - c. Life vests;
 - d. Lifebuoys;
- To direct the CDRRMO and relevant departments to ensure the immediate distribution of these materials to Barangay and City Rescue and Response Teams.
