WHEREAS, Republic Act No. 10121, also known as the "Philippine Disaster Risk Reduction and Management Act of 2010," mandates local government units to implement measures that enhance disaster preparedness and risk reduction, including effective communication strategies;

WHEREAS, the recent challenges posed by disasters and crises have highlighted the need for a comprehensive, inclusive, and well-structured communication plan to provide timely, accurate, and actionable information to the public during emergencies;

WHEREAS, a Crisis and Disaster Risk Reduction and Management (DRRM) Communication Plan is essential for ensuring efficient coordination among government agencies, non-government organizations, and other stakeholders, while enhancing the city's capacity to manage public information during crises and disasters;

WHEREAS, the City Disaster Risk Reduction and Management Council recognizes the importance of forming a dedicated Technical Working Group (TWG) to develop a communication plan that is inclusive, aligned with existing DRRM frameworks, and responsive to the needs of Naga City's communities;

NOW, THEREFORE, on motion duly seconded, the City Disaster Risk Reduction and Management Council resolves:

- To create a Technical Working Group (TWG) composed of the following members:
 - a. The Head of the City Events, Protocol, and Public Information Office (CEPPIO)
 - A representative from the City Disaster Risk Reduction and Management Office (CDRRMO)
 - c. A representative from the City Planning and Development Office (CPDO)

 - Promotes multi-sectoral collaboration and community engagement;
 - Aligns with national and local DRRM frameworks and communication policies; and
 - Includes provisions for addressing the needs of vulnerable and marginalized sectors.
 - e. To require the TWG to present its draft plan to the City Disaster Risk Reduction and Management Council for review, approval, and endorsement to the Sangguniang Panlungsod for adoption and implementation.

RESOLVED FURTHER, that this resolution be disseminated to all concerned offices and stakeholders for their information and appropriate action.
