RESOLUTION AMENDING THE ROUTE STRUCTURE OF LOOP SERVICES "C" AND "D" UNDER THE AUTHORIZED 90-DAY DRY RUN OF THE APPROVED LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP), TO DETERMINE THE EFFECTIVENESS OF THE PROPOSED PUJ RATIONALIZED ROUTES:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is a copy of the Department of Transportation (DOTr) approved and endorsed to the Land Transportation Franchising and Regulatory Board (LTFRB) proposed LPTRP with rationalized routes under the proposed Public Utility Jeepney (PUJ) Rationalized Routes;

WHEREAS, the need to revise the route structures of Loop Services "C" and "D" under Resolution No. 2025-128, to include J. Miranda Avenue was identified to better serve the commuting public and enhance connectivity across key areas of Naga City;

NOW, THEREFORE, on motion of Hon. Melvin Ramon G. Buenafe, duly seconded by Hon. Jessie R. Albeus and Hon. Jose C. Rañola;

BE IT RESOLVED, as it is hereby resolved, to amend the route structure of Loop Services "C" & "D" to include J. Miranda Avenue in their respective route structures, to wit:

Route Name : Naga Loop Service "C" Route Structure: From General Luna St. - P. Burgos St.-Peñafrancia Ave. - Diaz St. - Elias Angeles St. - Bagumbayan St. - M.T. Villanueva Ave. - Magsaysay Ave. - <u>J.</u> <u>Miranda Ave.</u> - Roxas Ave. - Fraternidad St. - Biak-na-Bato St. - back to Gen. Luna St.

Route Name : Naga Loop Service "D" Route Structure: From General Luna St. - Biak-na-Bato St.-Fraternidad St. - Roxas Ave. - Magsaysay Ave. - <u>J. Miranda Ave.</u> - M.T. Villanueva Ave. - Bagumbayan St. - Elias Angeles St. - Caceres St. - back to Gen. Luna St.

BE IT RESOLVED FURTHER, as it is hereby further resolved, to maintain the ongoing 90-Day Dry Run of the LPTRP with these revised routes and ensure appropriate monitoring and evaluation of the operational impact of this amendment. RESOLUTION NO. 2025-172 Series of 2025
