WHEREAS, the Professional Regulation Commission (PRC) is scheduled to hold the Criminology Licensure Examination (CLE) on August 1 to 3, 2025, in various locations across the country, and in the Bicol Region, it will be held in Legazpi City, in Albay Province;

WHEREAS, the number of examinees in this licensure examination from Camarines provinces are dramatically increasing in recent years primarily because of the presence of a number of colleges and universities in these localities offering quality education in criminal justice, producing a number of topnotchers in recent licensure examinations and successful professionals through the years, and the renewed interest among Bicolano families, especially among the youth and aspiring students, to pursue criminal justice education for better opportunities and the nobility of the profession;
