

A RESOLUTION DIRECTING THE CIVIL SOCIETY ORGANIZATION (CSO) DESK OFFICER TO ISSUE A NOTICE OF CALL FOR ACCREDITATION TO ALL NON-ACCREDITED CIVIL SOCIETY ORGANIZATIONS (CSOs) IN NAGA CITY IN COMPLIANCE WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT MEMORANDUM CIRCULAR NO. 2025-060: -

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular No. 2025-060 titled "Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies," which establishes the uniform guidelines to strengthen the people's participation in local governance and development processes through the accreditation of Civil Society Organizations (CSOs) and the selection of their representative to local government special bodies;

WHEREAS, Executive Order 2021-003 of Naga City created Civil Society Organization (CSO) Desk tasked to mobilize, facilitate, and ensure the meaningful participation of accredited and recognized CSOs in various government processes, projects, and activities;

WHEREAS, pursuant to Executive Order No. 2021-003 and City Ordinance No. 1995-092, the CSO desk officer is mandated to assist CSOs in their application for accreditation and to endorse the fully compliant applications to the Sangguniang Panlungsod for evaluation and approval;

WHEREAS, the CSO Desk Officer is expected to conduct an inventory and update the directory of existing CSOs in Naga City in accordance with DILG Memorandum Circular No. 2025-060;

WHEREAS, the next procedural requirement under the DILG guidelines is for the Sangguniang Panlungsod, in coordination with the CSO Desk Officer, to issue a public Notice of Call for Accreditation to all non-accredited and potential CSOs to submit their applications for accreditation;

NOW THEREFORE, on motion of Hon. Gilda Gayle R. Abonal-Gomez, duly seconded by Hon. Jessie R. Albeus and Hon. Vito C. Borja II;

BE IT RESOLVED, as it is hereby resolved, to direct the Civil Society Organization (CSO) Desk Officer to issue a formal Notice of Call for Accreditation to non-accredited Civil Society Organizations (CSOs) in Naga City in strict compliance with the guidelines provided under Department of Interior and Local Government Memorandum Circular No. 2025-060.

LET COPIES of this resolution be furnished to the Honorable City Mayor and the designated CSO Desk Officer under EO 2025-019, Mr. Dave Bercasio, the DILG City Director, and all other offices concerned for their information and appropriate action.






