ORDINANCE NO. 2019-077

AN ORDINANCE REVERTING TO UNAPPROPRIATED BALANCE THE AMOUNT OF ONE MILLION THIRTY NINE THOUSAND EIGHT HUNDRED TWENTY PESOS (P1,039,820.00) FROM CAPITAL OUTLAY, AND APPROPRIATING THE SAME TO MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF THE CITY ENGINEER'S OFFICE TO COVER THE URGENT REPAIR AND MAINTENANCE WORKS AT THE BICOL SCIENCE AND TECHNOLOGY CENTRUM (BSTC), CITY COLLEGE OF NAGA, RAUL S. ROCO LIBRARY AND THE CONSTRUCTION OF STAGE AT THE JMR COLISEUM: -
