AN ORDINANCE REVERTING TO UNAPPROPRIATED BALANCE THE AMOUNT OF TWENTY ONE MILLION PESOS (P21,000,000.00) FROM THE UNUTILIZED CAPITAL OUTLAY APPROPRIATIONS OF VARIOUS OFFICES, AND APPROPRIATING THE AMOUNT OF ELEVEN MILLION SEVEN HUNDRED NINETY THREE THOUSAND THREE HUNDRED SEVENTY ONE PESOS (P11,793,371.00) TO LAND UNDER THE OFFICE OF THE CITY MAYOR TO COVER PART OF THE JUST COMPENSATION OF THE OWNER TO BE AFFECTED BY THE EXPROPRIATION OF CERTAIN LOTS IN BARANGAY STA, CRUZ, THIS CITY, WHERE THE PROPOSED PUBLIC HIGH SCHOOL, SATELLITE MARKET, EVACUATION CENTER, CITY HEALTH OFFICE II, AND POLICE AND FIRE SUBSTATIONS WILL BE LOCATED:-

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - The amount of Twenty One Million Pesos (P21,000,000.00) from the unutilized capital outlay appropriations of various offices is hereby reverted to unappropriated balance, and the amount of Eleven Million Seven Hundred Ninety Three Thousand Three Hundred Seventy One Pesos (P11,793,371.00) thereof is hereby appropriated to Land under the Office of the City Mayor to cover part of the just compensation of the owner to be affected by the expropriation of certain lots in Barangay Sta, Cruz, this city, where the proposed Public High School, Satellite Market, Evacuation Center, City Health Office II, and Police and Fire Substations will be located:
