AN ORDINANCE REVERTING THE UNAPPROPRIATED BALANCE THE AMOUNT OF FORTY THOUSAND FIVE HUNDRED PESOS (P40,500.00) FROM SALARY SAVINGS AND APPROPRIATING THE SAME TO SPECIAL PURPOSE APPROPRIATION-ESSENTIAL COMMUNITY SERVICES TO COVER THE ADJUSTMENT IN THE BARANGAY PERFORMANCE INCENTIVE TO BARANGAY TREASURERS, SECRETARIES AND RECORD KEEPERS FROM THREE THOUSAND PESOS (P3,000.00) TO THREE THOUSAND FIVE HUNDRED PESOS (P3,500.00) EACH:-

On joint and collective motion

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - The amount of Forty Thousand Five Hundred Pesos (P40,500.00) is hereby reverted to unappropriated balance and appropriated to Special Purpose Appropriation -Essential Community Services to cover the adjustment in the Barangay Performance Incentive to barangay treasurers, secretaries and record keepers from Three Thousand Pesos (P3,000.00) to Three Thousand Five Hundred Pesos (P3,500.00) each;

SECTION 2. - This ordinance shall take effect upon its approval.




