ORDINANCE NO. 2020 -070

AN ORDINANCE REVERTING TO UNAPPROPRIATED BALANCE THE AMOUNT OF TWO MILLION SEVEN HUNDRED SEVENTY TWO THOUSAND TWO HUNDRED PESOS (P2,772,200.00) FROM "WELFARE GOODS' ACCOUNT OF THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE, AND APPROPRIATING THE SAME TO "DONATION" UNDER THE PUBLIC SAFETY OFFICE FOR THE PURPOSE OF PAYING THE HONORARIA OF PRIVATE VOLUNTEERS WHO RENDERED SERVICE DURING THE ENHANCED AND GENERAL COMMUNITY QUARANTINES IN NAGA CITY COVERING THE PERIOD MARCH 17 TO MAY 31, 2020 AT THE RATE OF TWO HUNDRED PESOS (P200.00) PER DAY: -

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - The amount of Two Million Seven Hundred Seventy Two Thousand Two Hundred Pesos (P2,772,200.00) from "Welfare Goods' Account of the City Social Welfare and Development Office is hereby reverted to unappropriated balance, and appropriated to "Donation" under the Public Safety Office for the purpose of paying the honoraria of private volunteers who rendered service during the Enhanced and General Community Quarantines in Naga City covering the period March 17 to May 31, 2020 at the rate of Two Hundred Pesos (P200.00) per day;

SECTION 2. - This ordinance shall take effect upon its approval.
