AN ORDINANCE AMENDING SECTION 6 OF ORDINANCE NO. 2020-082, ENTITLED: "AN ORDINANCE ADOPTING THE COVID-19 CONTAINMENT PROJECT, HARNESSING BARANGAY VOLUNTEER FRONTLINE WORKERS, AUTHORIZING THE GRANT OF HONORARIUM, AND PROVIDING FUNDS FOR THE PURPOSE", BY RECTIFYING THE RATES FOR CHIEF TANOD, BARANGAY NUTRITION SCHOLARS AND BARANGAY SERVICE POINT OFFICERS:-

Be it ordained by the Sangguniang Panlungsod of Naga, that:

**SECTION 1.** - Section 6 of Ordinance No. 2020-082, entitled: "An ordinance adopting the COVID-19 Containment Project, harnessing barangay volunteer frontline workers, authorizing the grant of honorarium, and providing funds for the purpose", is hereby amended by rectifying the rates for Chief Tanod, Barangay Nutrition Scholars and Barangay Service Point Officers, now to read as follows:

"Section. 6. Grant of honoraria to Barangay Volunteer Frontline Workers. The following rates of honoraria per month are herein granted to Barangay Volunteer Frontline Workers engaged in the Covid-19 Containment Project:

a. Barangay Health Workers - Accredited	P 2,300.00
b. Barangay Health workers - Recognized	1,940.00
c. <u>Barangay Nutrition Scholars</u>	<u>4,500.00</u>
d. <u>Barangay Service Point Officers</u>	<u>3,300.00</u>
e. Supplemental Feeding Volunteer	2,200.00
f. <u>Chief Tanod</u>	<u>2,300.00</u>
g. Barangay Electrician	1,000.00
h. Social Welfare Volunteer	3,300.00
i. Community Based Rehabilitation Specialist	2,800.00
j. Barangay Health Encoder	2,000.00

**SECTION 2. Effectivity.** This Ordinance shall take effect upon its approval.
