## ORDINANCE NO. 2020-116

AN ORDINANCE AUTHORIZING THE GRANT OF TWENTY FIVE THOUSAND PESOS (P25,000.00) COLLECTIVE NEGOTIATION AGREEMENT (CNA) INCENTIVE TO ALL EMPLOYEES OF THE CITY GOVERNMENT AND FOR THIS PURPOSE REVERTING TO UNAPPROPRIATED BALANCE THE AMOUNT OF THIRTY TWO MILLION FIVE HUNDRED THOUSAND PESOS (P32,500,000.00) FROM SAVINGS OF CERTAIN ACCOUNTS UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF VARIOUS OFFICES AUTHORIZED UNDER BUDGET CIRCULAR 2020-5 TO BE SOURCES OF CNA INCENTIVE, AND APPROPRIATING THE SAME TO OTHER PERSONNEL BENEFITS (CNA BONUS) UNDER THE OFFICE OF THE CITY MAYOR:-

On joint and collective motion

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - The grant of amount of Twenty Five Thousand Pesos (P25,000.00) Collective Negotiation Agreement (CNA) Incentive to all employees of the city government is hereby granted and for this purpose reverting to unappropriated balance the amount of Thirty Two Million Five Hundred Thousand Pesos (P32,500,000.00) from savings of certain accounts under the Maintenance and Other Operating Expenses (MOOE) of various offices authorized under Budget Circular 2020-5 to be sources of CNA Incentive, and appropriating the same to Other Personnel Benefits (CNA Bonus) under the Office of the City Mayor;

SECTION 2. - This ordinance shall take effect upon its approval.
