ORDINANCE NO. 2020-119

AN ORDINANCE AUTHORIZING THE GRANT OF SERVICE RECOGNITION INCENTIVE TO THE CITY'S 475 WASTE RECYCLERS/INFORMAL WORKERS IN THE AMOUNT OF ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) EACH, AND FOR THIS PURPOSE REVERTING TO UNAPPROPRIATED BALANCE THE AMOUNT OF SEVEN HUNDRED TWELVE THOUSAND FIVE HUNDRED PESOS (P712,500.00) FROM "OTHER MAINTENANCE AND OPERATING EXPENSES" OF THE SOLID WASTE MANAGEMENT OFFICE, AND APPROPRIATING THE SAME TO "DONATION" UNDER THE SAME OFFICE:-

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - The grant of Service Recognition Incentive to the city's 475 waste recyclers/informal workers in the amount of One Thousand Five Hundred Pesos (P1,500.00) each is hereby authorized, and for this purpose reverting to unappropriated balance the amount of Seven Hundred Twelve Thousand Five Hundred Pesos (P712,500.00) from "Other Maintenance and Operating Expenses" of the Solid Waste Management Office, and appropriating the same to "Donation" under the same office;
