

ORDINANCE NO. 2021-023

AN ORDINANCE AMENDING ORDINANCE NO. 2020-131, ENTITLED: "AN ORDINANCE AUTHORIZING THE PAYMENT OF TAXES, DUTIES, PENALTIES AND OTHER FEES TO THE BUREAU OF INTERNAL REVENUE RELATIVE TO THE DONATION AND SALE OF A 30,000 SQUARE METER PROPERTY OF DOMINADOR T. ALMEDA AND SONS, INC. IN FAVOR OF THE CITY OF NAGA, AND APPROPRIATING THE AMOUNT OF FOUR HUNDRED THIRTY THOUSAND EIGHT HUNDRED SEVENTY FOUR AND 48/100 PESOS (P430,874.48) FOR THIS PURPOSE, CHARGEABLE AGAINST THE LOCAL DEVELOPMENT FUND-DECENTRALIZED SERVICES", BY CHANGING THE AMOUNT TO FOUR HUNDRED THIRTY FIVE THOUSAND SEVENTY SEVEN & 79/100 PESOS (P435,077.79):-

On joint and collective motion

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - Ordinance No. 2020-131, entitled; "An ordinance authorizing the payment of taxes, duties, penalties and other fees to the Bureau of Internal Revenue relative to the donation and sale of a 30,000 square-meter property of Dominador T. Almeda And Sons, Inc. in favor of the City of Naga is hereby authorized, and the amount of Four Hundred Thirty Thousand Eight Hundred Seventy Four And 48/100 Pesos (P430,874.48) is hereby appropriated for this purpose, chargeable against the Local Development Fund-Decentralized Services" is hereby amended by changing the amount to Four Hundred Thirty Five Thousand Seventy Seven & 79/100 Pesos (P435,077.79);

SECTION 2. - This ordinance shall take effect upon its approval.
