



**EXECUTIVE ORDER NO. 053**

**DIRECTING THE SUSPENSION OF CLASSES AT ALL LEVELS IN BOTH  
PUBLIC AND PRIVATE LEARNING INSTITUTIONS AND THE  
SUSPENSION OF WORK IN ALL GOVERNMENT OFFICES IN THE CITY  
OF NAGA ON 26 SEPTEMBER 2025 DUE TO TYPHOON "OPONG"**

**WHEREAS**, Memorandum Circular No. 102 issued by the Office of the President, upon the recommendation of the National Disaster Risk Reduction and Management Council, suspended work in government offices and classes at all levels in specified provinces, and further authorized local chief executives to implement localized suspension of work and/or classes within their respective jurisdictions to ensure public safety;

**WHEREAS**, the latest weather advisories from PAGASA on Typhoon Opong indicate intensified rains and possible strong winds affecting the Bicol Region, including the City of Naga;

**WHEREAS**, the City Government recognizes the urgent need to safeguard the welfare of students and the general public against the adverse weather conditions expected to prevail within the City of Naga;

**NOW, THEREFORE, I, MARIA LEONOR G. ROBREDO**, Mayor of the City of Naga by virtue of the powers vested in me under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, do hereby order the following:

**SECTION 1. SUSPENSION OF CLASSES.** Classes at all levels in both public and private learning institutions within the territorial jurisdiction of the City of Naga are hereby suspended on Friday, 26 September 2025.



**SECTION 2. SUSPENSION OF WORK IN GOVERNMENT OFFICES.** Work in all government offices within the territorial jurisdiction of the City of Naga, including national government agencies with local offices, is likewise suspended on Friday, 26 September 2025.

However, personnel involved in disaster response, medical and health services, peace and order, emergency operations, traffic management, sanitation, and other vital functions shall continue to perform their duties to ensure uninterrupted delivery of critical public services.

**SECTION 3. WORK IN PRIVATE OFFICES.** In accordance with Memorandum Circular No. 102, suspension of work in private companies and offices is left to the sound discretion of their respective management, taking into consideration public safety and employee welfare.

**SECTION 4. AMENDMENTS AND INTERPRETATION.** This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

**SECTION 5. REPEALING CLAUSE.** All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

**SECTION 6. SEPARABILITY CLAUSE.** If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 7. EFFECTIVITY.** This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
