



**EXECUTIVE ORDER NO. 011**

**ESTABLISHING THE CITY AWARDS COMMITTEE FOR THE 2026 LUPONG  
TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) OF NAGA CITY**

**WHEREAS**, the *Lupong Tagapamayapa* was institutionalized under Presidential Decree No. 1508 and subsequently strengthened under Chapter VII of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to promote the amicable settlement of disputes at the barangay level and decongest court dockets;

**WHEREAS**, Executive Order No. 394, Series of 1997 established the Lupong Tagapamayapa Incentives Awards (LTIA) to recognize outstanding performance in the implementation of the Katarungang Pambarangay system;

**WHEREAS**, the Department of the Interior and Local Government (DILG), through Memorandum Circular No. 2023-022 and Memorandum Circular No. 2024-174, provides the enhanced criteria and guidelines for the conduct of the LTIA and requires the creation of a City Awards Committee (CAC) to evaluate and endorse the City's official entry to the Regional Awards Committee;

**WHEREAS**, the City Government of Naga recognizes the vital role of the Lupong Tagapamayapa in maintaining peace and order, strengthening community-based dispute resolution mechanisms, and promoting access to justice at the grassroots level;

**WHEREAS**, there is a need to formally constitute the City Awards Committee to conduct the 4-Day Table Assessment on March 10–13, 2026 and the 3-Day Onsite Validation on March 16–18, 2026, and to select and endorse the City's official nominee for Performance Year 2025 to the Regional Awards Committee;

**NOW THEREFORE, I, MARIA LEONOR G. ROBREDO**, Mayor of Naga City, by virtue of the powers vested in me by law, do hereby order:

**SECTION 1. CREATION OF THE CITY AWARDS COMMITTEE.** There is hereby created a City Awards Committee (CAC) for the 2026 Lupong Tagapamayapa Incentives Awards (LTIA) of Naga City.



**SECTION 2. COMPOSITION.** The City Awards Committee shall be composed of the following:

**SECTION 3. POWERS AND FUNCTIONS.** The City Awards Committee shall:

- a. Conduct the Table Assessment of all Lupong Tagapamayapa in the twenty-seven (27) barangays of Naga City for Performance Year 2025;
- b. Undertake Onsite Validation of the Top Ten (10) performing Lupong Tagapamayapa to verify submitted documents and assess actual Katarungang Pambarangay operations;
- c. Evaluate and rank the barangays in accordance with the criteria set forth by the DILG under the LTIA guidelines;
- d. Select and endorse to the Regional Awards Committee the official entry of the City of Naga for the 2026 Lupong Tagapamayapa Incentives Awards; and
- e. Recommend measures to further strengthen the implementation of the Katarungang Pambarangay system in the City.



**SECTION 4. ADMINISTRATIVE AND LOGISTICAL SUPPORT.** The City Government, through the appropriate offices, shall provide the necessary administrative and logistical support for the conduct of the Table Assessment and Onsite Validation, including meals, supplies, transportation, and other incidental expenses chargeable against the appropriate fund, subject to existing accounting and auditing rules and regulations.

**SECTION 5. AMENDMENTS AND INTERPRETATION.** This Order may be amended or supplemented as may be deemed necessary, and shall be interpreted to give full force and effect to the attainment of the declared policy and the operationalization of the principles of good governance.

**SECTION 6. REPEALING CLAUSE.** All issuances and orders inconsistent with this Order are hereby repealed, amended, or modified accordingly.

**SECTION 7. SEPARABILITY CLAUSE.** If any provision of this Order is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 8. EFFECTIVITY.** This Order shall take effect immediately and shall remain in effect unless otherwise revoked or amended, or until superseded by an ordinance.
